

Dear ones in Christ,

Greetings in His wonderous working Name.

**Our Vision** is to reach the unreached high caste villages of India. Therefore, my wife Santha, daughter Praisie, and myself moved to Madurai at the above address, on June 1, 2002; leaving our home of 37 years in Nagercoil. The ministry of Robert de Nobili was carried out in this area about 300 years ago, but due to the recent anti-conversion law within the state of Tamil Nadu, the Christian witness has suffered.

**Our Need:** Most of the receptive people groups in India have been reached by the Gospel through various NGO's and churches. But resisting and persecuting groups still exist in every district and state of India and have been neglected by almost all ministries. Usually the temple authorities and villages leaders have organized a system to resist and oppose missionaries, even resorting to physical abuse.

**Our Approach:** Many villages are closed to the Gospel in India but the love of God compels us to reach them any way. Unlike the missionary model in India to reach the lower caste first, we feel called to reach the high caste first since they influence the community. We target villages with 2000 to 3000 families where the majority are high caste. FIRST, we approach the high caste families in searching for a house to rent for our ministry center. SECOND, we establish centers for adult education. THIRD, we require our missionaries stay in the rented houses to preach the Gospel by being and doing rather than speaking first. FOURTH, we invite the missionaries back to Madurai once a week for spiritual renewal, edification, sharing, and prayer. FIFTH, we train our missionaries how to do evangelism within a militant Hindu culture.

**Our Request:** At present we are 22 missionaries, including two who joined in February 2003. Our request is for you to sponsor our missionaries either as a family, small group, or church by adopting a missionary at \$ 75 per month. Further we are in need of a hall to gather the believers for spiritual nourishment and education. It will cost a minimum of \$ 1,000 a year for each center. We are currently reviewing applications from experienced missionaries who have been guided by the Lord to join us in reaching the unreached people of India. Please prayerfully consider joining us in this interdenominational effort to bring the hope of Jesus Christ to the state of Tamil Nadu.

Mr. Binu is a missionary in the tribal area of Kerala. By his repeated fasting and prayer, he is overcoming the evil power of the magicians around him. He has a genuine testimony and work for the Lord.



9. Mr. K. Peter Ponnusamy

Mr. Ponnusamy is a tribal convert and he works among the tribes of Kolli hills, Tamil Nadu with signs and wonders in his ministry.
